*Bill 3147**by Judy Calloway*

Texas Farm Land & Ranches

SB #147 A bill to protect Texas farm and ranch lands. Prohibiting foreign countries and it's entities from buying Texas lands and any mineral rights. Senator Lois Kolkorst a Republican from Houston introduced this bill in 88th Legislature. Several Chinese American are protesting this bill saying it is depriving them of the American Dream. If a Chinese has an American citizenship this does not apply to them. This is not about buying a house in Houston, Austin, or Amarillo. It is about buying huge tracts of land with all mineral rights for countries such as China, Russia, Iraq, North Korea. Texas is one of 8 states that does not have this type of law on the books. Below is the actual bill as submitted:

relating to the purchase of or acquisition of title to real property by certain aliens or foreign entities. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTIONA1.AASection 5.005, Property Code, is amended to read as follows: Sec.A5.005.AAA LIENS. AA Except as provided by Section 5.0051, an [An] alien has the same real and personal property rights as a United States citizen.

SECTIONA2.AASubchapter A, Chapter 5, Property Code, is amended by adding Section 5.0051 to read as follows:

Sec.A5. 0051.AA PURCHASE OF OR ACQUISITION OF TITLE TO REAL PROPERTY BY CERTAIN FOREIGN INDIVIDUALS OR ENTITIES PROHIBITED. Notwithstanding any other law, the following may not purchase or otherwise acquire title to real property in this state: (1)AA a governmental entity of China, Iran, North Korea, or Russia; (2)AA a company or other entity that is: (A)AA headquartered in China, Iran, North Korea, or Russia; (B)AA directly or indirectly held or controlled by the government of China, Iran, North Korea, or Russia; or (C)AA owned by or the majority of stock or other ownership interest of which is held or controlled by individuals who are citizens of China, Iran, North Korea, or Russia; (3)AA a company or other entity that is owned by or the majority of stock or other ownership interest of which is held or controlled by a company or entity described by Subdivision (2); or (4)AA an individual who is a citizen of China, Iran, North Korea, or Russia.

SECTIONA3.AAThe changes in law made by this Act apply only to the purchase of or other acquisition of title to real property on or after the effective date of this Act. The purchase of or other acquisition of title to real property before the effective date of this Act is governed by the law in effect immediately before the effective date of this Act, and that law is continued in effect for that purpose.

SECTIONA4.AAThis Act takes effect September 1, 2023.

State sales tax revenue totaled \$3.7B in February

Texas Comptroller Glenn Hegar announced Wednesday state sales tax revenue totaled \$3.68 billion in February, 14.2 percent more than in February 2022.

The majority of February sales tax revenue is based on sales made in January and remitted to the agency in February.

“Propelled by continued strong business spending and a surprising post-holiday surge in consumer spending, growth in February sales tax receipts significantly outpaced inflation, which is still hovering over 6 percent,” Hegar said in the press release. “Robust increases in receipts from all major sectors suggest economic activity in the state is not yet slowing significantly despite high interest rates and fears of recession.

“As has been the case in recent months, receipts from sectors driven primarily by business spending showed the greatest rates of growth, with receipts from the oil and gas mining, manufacturing and construction sectors coming in strongly above February 2022 totals.

“Remittances from the retail trade sector – the sector responsible for the largest portion of state sales tax – grew much faster than the rate of inflation for consumer goods. The retail segments with the fastest growth in tax receipts were general merchandise and clothing stores.

“Receipts from the services sector were up double digits, led by receipts for live entertainment venues. Receipts from restaurants were also up double digits compared with February of last year, significantly outpacing the rate of inflation for food away from home.”

Total sales tax revenue for the three months ending in February 2023 was up 10.2 percent compared with the same period a year ago. Sales tax is the largest source of state funding for the state budget, accounting for 56 percent of all tax collections.

Texas collected the following revenue from other major taxes:

>> Motor vehicle sales and rental taxes — \$542 million, up 14 percent from February 2022.

>> Motor fuel taxes — \$304 million, up 1 percent from February 2022.

>> Oil production tax — \$492 million, up 2 percent from February 2022.

>> Natural gas production tax — \$305 million, down 5 percent from February 2022.

PITTSBURGH (KDKA) 1/7/23- Despite a volatile year for crude oil prices, they ended the year similarly to how they began at around \$80 a barrel.

The last time prices were as high as they reached this year was in 2014. U.S. production increased by about 400,000 barrels per day this year, and OPEC's management of oil production helped to stabilize prices by the end of the year.

Although it's almost impossible to predict oil prices, the president of Cargile Investment Management, Mickey Cargile, has his own theory about what could happen in 2023.

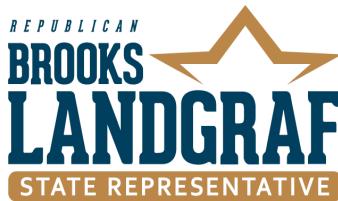
"I think you're going to see prices move higher. OPEC has done an excellent job of managing inventories and keeping the price stable, but I also think the domestic producers have done a wonderful job at managing their capital expenditures to control the amount of oil they're producing so that we don't have these unstable prices," Cargile said. Cargile said there is a high chance we are starting the year at a low for oil and gas prices.

Standing Texas STRONG

February 19, 2023

In Texas, we have something called “horse sense,” with thinking being that the best ideas are usually ones that can be explained so easily that even a horse could understand.

This legislative session I have offered an idea to the state legislature that I think makes a whole lot of horse sense. I’ve offered a bill that would re-invest state oil and natural gas production tax (aka “severance tax”) revenue back in the communities responsible for generating the lion’s share of that revenue.

It’s not just about improving quality of life in the oilfield, it’s about doing what is necessary so that Texas can be a global force for good. It’s about defending the Texas energy industry because of its importance to our state budget and economy as well as geopolitics and American freedom. It’s about making Texas strong.

The Texas Severance Tax Revenue and Oil and Natural Gas (STRONG) Defense Fund would keep a portion of state severance tax revenue and invest it in regions of the state significantly affected by energy production. Texas STRONG funds will support transportation infrastructure, workforce and economic development, public education, healthcare, and public safety needs in the regions of the state where oil and natural gas production are the highest.

I filed House Joint Resolution 111 and House Bill 2207 because I believe that what’s best for the Permian Basin is what’s best for the Lone Star State. HJR 111 seeks to amend the Constitution to create the Texas STRONG Defense Fund and HB 2207 sets out how the funds can be used. It’s going to take a lot of work, but it will be worth it if we are able to secure energy independence for future generations of Texans. A plus this time is that you will get the chance to vote on this yourself in November if we are successful.

Currently, severance taxes are deposited in the state general revenue fund, state highway fund and rainy day fund with part of the deposits in general revenue earmarked for public education. Since 2014, severance taxes have contributed \$9 billion to public education, \$13.3 billion to the state highway fund and \$13.3 billion to the rainy day fund. Over that same timespan, a small portion (32 out of 254) of Texas counties generated 80% of the severance tax revenue for a total of nearly \$40 billion. As you can imagine, the majority of those counties are located right here in the Permian Basin.

With HJR 111 and HB 2207, a portion of the severance tax revenue that would otherwise be deposited in the now overflowing rainy day fund would instead go towards the Texas STRONG Defense Fund. Texas STRONG funds would help address everything from teacher and nursing shortages to potholes. Our streets would be made safer not just with repairs, but with additional boots and badges, ready and trained to enforce CMV laws.

HJR 111 caps deposits in the Texas STRONG Fund at \$500 million per year, with anything in excess of \$500 million going to the state’s property tax relief fund. Yes, you read that right, we’re going to use oil and natural gas to lower property taxes statewide. Current projections show that deposits in the property tax relief fund could be as high as \$250 million in 2025 if my Texas STRONG proposal passes. HJR 111 would also dedicate some severance tax revenue to plug orphaned wells and clean up Texas air and groundwater contamination. This is all possible without touching any of the severance tax revenue that



goes towards public education and the state highway fund.

I was elected by the hard-working people of House District 81 to be their voice in the Texas House of Representatives. It's impossible to articulate how proud I am to serve such incredible people. You elected me to fight for what's right, to do the hard work for the results, not the credit. That is why I am going to fight tooth and nail to pass Texas STRONG this session. Horse sense or not, it's the right thing to do for Texas.

*Texas 88th Legislative Session in Full Swing**by Judy Calloway*

Legislative Session convened on Tuesday January 10, 2023.

November 14th was the first day that legislators could file bills for the 88th Legislature, so before they even convened there were 100's of bills already filed. It is a mad rush to get bills into committee hearings and so many never make it past the committee hearing.

On February 16th Governor Abbott delivered his 2023 State of Texas Address. In this address, he focused on seven emergency items which are his priorities for the 88th Legislative session.

1. Reducing property taxes
2. Ending COVID-19 restrictions forever in Texas
3. School Safety
4. Educational freedom, specifically for parents
5. Ending the "revolving door bail"
6. Securing the U.S-Mexico border
7. Fighting the fentanyl crisis

Property Tax Relief: Will use \$15 billion of the largest budget surplus in state history to cut property tax. Accomplish by lowering school districts M&O tax rate by increasing the tax rate compression, providing relief for ALL property owners. Provide relief to small businesses by increasing the business property tax exception. Require local government debt to be passed by two-thirds supermajority of the local governing body. Require local bond issues not included in on the November ballot be passed by a majority two-thirds majority of voters. Has already increased the homestead exemption from \$25,000 to \$40,000 that was approved by voter in the November 22 ballot

Working with Texas Legislature in this session will prohibit.

- : Any **COVID-19** vaccine mandates
- : Any **COVID-19** mask mandates through disaster declaration, ordinance, or any other action
- : Any government from closing any business or school because of **COVID-19**

He has already banned vaccine passports (87R SB698), prevented local governments from shutting down religious activities during a pandemic (87HR HB1992) prohibited local governments from shutting down certain business activities (87R SB968)

School Safety has had many significant actions taken in 2022 to increase safety standards and practices on school campuses across Texas. Including the creation of Texas Child Mental Health Care Consortium (TCMHCC), provided over \$1 billion in school safety funding since 2019, directed Texas Education Agency (TEA) to create a new Chief of School Safety and Security to collaborate with state agencies for a safer environment by October 2022. Directed the Texas School Safety Center (TxSSC) to conduct comprehensive school safety reviews by June 2022, Instructed the Advance Law Enforcement Rapid Response Training (ALERTT) programs to provide training to all school districts statewide, prioritizing school based law enforcement (June 2022)

This session the Governor will work with Texas Legislature to add.
 Funding for every school campus to make necessary school safety improvement.
 Expand and enhance the capabilities of *iWatchTexas* in school districts.
 Require school campus maps to be provided to local law enforcement for enhanced response to disaster, Codify the intruder detection audit process & require facilities to use those standards
 Increase funds for TCHATT to ensure Texas Students are connected to mental health services they need.

Use the newly created Chief of School Safety & Security to ensure compliance with all mandated safety standards.

EDUCATION FREEDOM Governor Abbott has already provided more funding for public education and funding for teacher pay increases (see 2022 TEA Annual Report) Achieved an all time high for statewide per-student funding through landmark school finance . Established the Teacher Incentive Allotment which award over \$55 million in pay raise for more than 6200 exemplary teachers.

Abbott will work with the Texas Legislature this session to:

Expand school choice options available thru FSAs to all students.
 Amend the Texas Constitution to bolster a parents right as the primary decision maker in all matters involving their child.
 Require school to inform parents of their right.
 Expand Parent succession to curriculum, school libraries, and what their children are taught.
 Allow a parent to decide if their child should repeat a grade.
 Strengthen consent requirements for health services.
 Protect students from unnecessary personal data collection and ensure schools are not sharing or selling student data outside the Texas public education system.

END REVOLVING DOOR BAIL

Governor Abbott made reforming. Texas broken bail system in the 87th Legislature to include:

Prohibited criminals charged with a violent offense to be released on personal bond (87R SB6)
 Required bail be set or denied within 48 hours of arrest and that criminal history be considered before setting bail (87 R SB6)
 Require bond conditions be reported to give law enforcement the ability to apprehend offenders out on bail that are violating court orders (87R SB6)

Texas had made great strides to protect our cities and Governor Abbott will work with 88th Legislature to strengthen our bail system by

Propose a constitutional amendment allowing judges to deny bail for the most offenders. Pass legislation to hold judges and district attorneys accountable of reckless decisions compromising the safety and security of Texans.

SECURE THE BORDER- Texas has done more than any state ever to secure our border including:

Secured over \$4 Billion in funding for Texas border efforts thru (87 SB1, HB2 :87(2), January 2022, April 2022, October 2022

Deployed thousands of Texas National Guard soldiers and Texas Department of Public Safety troopers to the border.

Seized enough Fentanyl to kill every man, woman, and child in the United States.

Arrested and jailed criminal for committing state crimes along the border.

Since launching Operation Lone Star Governor Abbott has taken unprecedented action to secure the border and provide support to local border officials including:

Designated Mexican Drug Cartels as terrorist organizations (September 2022)

Bused immigrants to Washington DC, New York City, Chicago, and Philadelphia

Hired the first ever Texas Border Czar (January 2023)

Abbott will work with the 88th Legislature to:

Secure an additional \$4.6 Billion to bolster border security.

Pass legislation making it at least a ten year mandatory jail sentence for anyone caught smuggling in Texas.

Enhance maximum penalty for operating a stash house to a third-degree felony.

Enhance criminal penalties for foreign terrorist organizations and increase intelligence operations against such organizations.

Increase penalties for smuggling and stash house operations when committed in a disaster area.

Fight the Fentanyl Crisis This is the leading killer of Americans between ages of 18-45.

Governor Abbott has taken unprecedented action to protect our communities from fentanyl including the following.

: Signed a law enhancing penalties for the manufacture and distribution of fentanyl (87R SB768)

: Designated Mexican drug cartels as terrorist organizations to keep Texas safe.

: Directed state agency leaders to ramp up efforts to respond to the fentanyl crisis (Sept. 2022)

: Launched the statewide “One Pill Kills” campaign to raise awareness of the deadly fentanyl plaguing Texas and United States (October 2022)

The governor will continue to combat the growing Fentanyl Crisis with help of 88th Legislature with the following :

- : Classify fentanyl “overdose” as poisoning.
- : Prosecute an individual for murder if they distribute fentanyl or drugs laced with fentanyl that kills someone.
- : Increase the supply of lifesaving NARCAN and make it more readily available to Texans exposed to Fentanyl across the state.

Swedish Pound Cake Recipe

Ingredients:

1 c. butter
2 c. sugar
5 eggs
2 c. sifted flour
1 tsp. vanilla
1 sm. Bag chocolate chips
1 c. flaked coconut
1 c. chopped nuts (pecans or walnuts)



GLAZE:

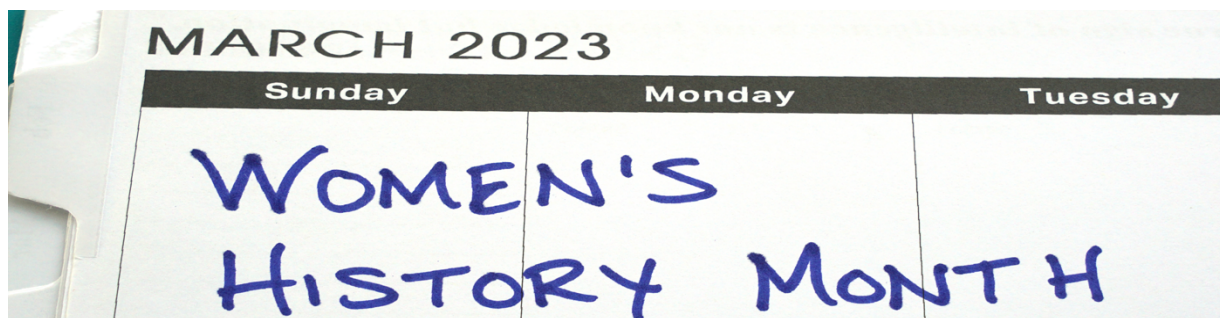
½-¾ c. sugar
½ - ¾ c. water
½ stick butter
1 tsp. almond extract

Instructions:

Cream butter and sugar. Add eggs and beat well. Stir in 2 cups of flour. Add vanilla, chocolate chips, coconut and nuts. Pour into greased and floured Bundt pan. Bake at 325 degrees at least 1 hour. Cool and remove from pan.

Glaze: Boil sugar and water 3 minutes and remove. Add butter and almond extract. Spread glaze with a pastry brush.

Suggestion: Pour ½ of glaze on before you dump it out of the pan. Then put the remainder on glaze on top.

Local TFRW Republican Clubs

How often do they meet?

ECRW once a month, except June and July.
Normally the third Wednesday. In December
ECRW has a membership/Christmas event.

County Republican Party

How often do they meet?

The Executive Committee shall meet
once a quarter. Per RPT Rules,
organizational meetings are to be called a
minimum 14 days' notice by the Party
Chairman. Please check local by-laws.

Qualifications for Local Club President

Any woman believing in the philosophy of the Republican
Party and of this organization. She shall be a registered voter.
Be in good standing with TFRW and NFRW by having paid the
required dues for the current calendar year.

Qualifications to be a County Chair

Be a qualified voter of the county. Not be a
County, state, or federal public officeholder or
candidate for such office, and in a general
election year, be affiliated with the republican
primary election or runoff or by oath of
affiliation.

Methods for becoming a club President

A nominating committee of not less than 3 and not more
than 5, at least one of whom shall not be a member of the
Executive Committee. The nominating Committee shall elect
its chairman for one of its own members. The Nominating
Committee shall report one nominee for each office at the
September meeting at least 30 days ahead of the election.

Methods for becoming a County Chair

Candidates for county chair run for office in
Primary Election each even-numbered
year. A one-page notarized application must be
submitted to the County Chair within a one
month filing period. Individuals wanting to
challenge the incumbent are required to
complete GOP form Nominating Petition for
Republican Party County Chair at least 10%
of the incumbent precinct chairs serving on the
County Executive Committee or two (2)
whichever is greater, using a form
promulgated by RPT.

Marine Sgt. Tyler Vargas-Andrews Recalls Kabul Airport Suicide Bombing

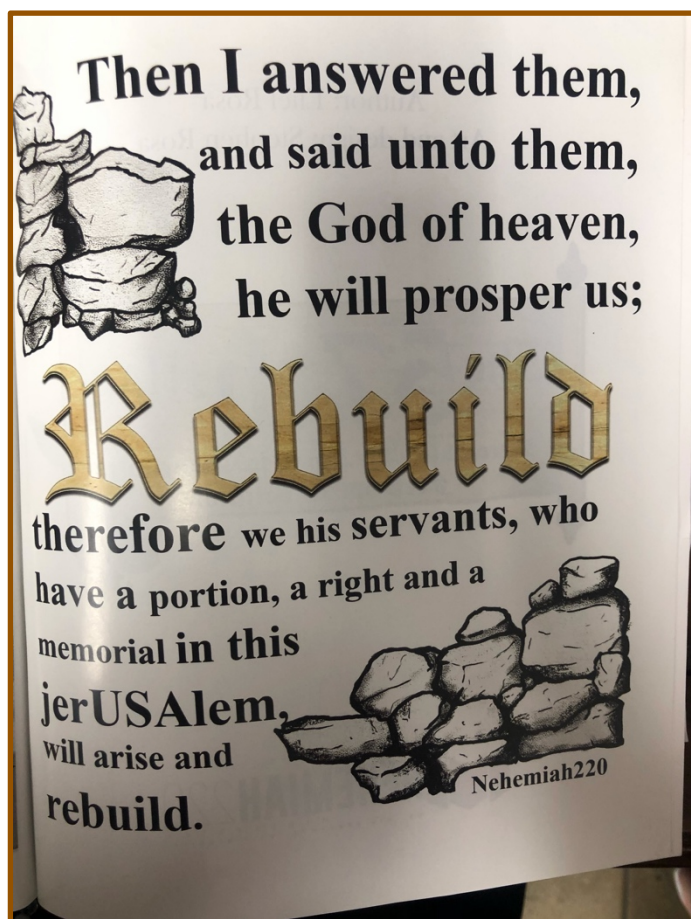

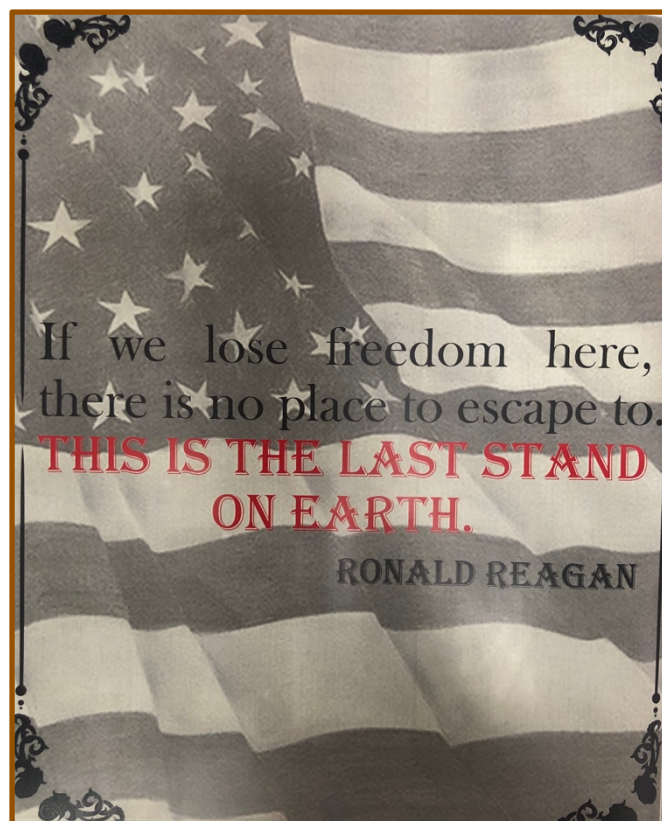

PROHIBITING DENIAL FOR PLACE ON BALLOT

Dear Members,

On Thursday, March 16th, the House Elections Committee will hold a hearing on [HB 1635](#) by Rep. Dustin Burrows (R-HD 83) which prohibits a party official (for example, a County Chair) from denying a candidate a place on the ballot who has otherwise complied with the requirements set forth in the Texas Election Code. While it might seem that such a bill should not be necessary, confusion caused by recent changes to political party rules require this clarification.

The Texas Election Code applies to all general, special and primary elections held in this state. Tex. Elec. Code § 1.002. Candidacy requirements are set by constitution or statute. See, e.g., Tex. Elec. Code § 141.001. HB 1635 seeks to reinforce that it is **the law**, not an individual's discretion, that determines whether a candidate's name appears on the ballot. Please contact the Members and Clerk of the Elections Committee (contact information below) to express your support for HB 1635.

Also, because this bill is pending in the House, you can "testify" without appearing in person any time until the hearing is adjourned by visiting the House witness testimony portal [HERE](#). You will be asked to certify that you are a Texas resident, provide your name, address and phone number, and SELECT HB 1635 by Burrows to enter your comments. Remember, you are not acting on behalf of your club or TFRW, so the Organization/Representing box should be left blank.
