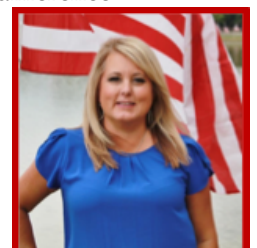

The Founders Weren't Wrong!

There are two political philosophies today in the US that believe that the Founders were wrong.

President Biden's Joint Address Fueled the Flames of Socialism

Biden's Border Crisis Continues to Spiral

Last week we received the disturbing news that 33 Guatemalan citizens were found in a home inside the Midland city limits.

Make no mistake—this is no longer a crisis at the border, this situation is impacting communities across the entire interior of the country. I fear there are many more houses just like this one across the United States. It is time for the Biden Administration to reverse course.

Dear Secretary Vilsack,

We write to you regarding our concerns for the Biden Administration's workplace safety decision-making, to urge this administration to follow local guidelines and re-open Farm Production and Conservation (FPAC) facilities to an operable capacity, and to request a meeting with you to discuss these matters. At a time when our nation's farmers are battling the uncertainty of an unprecedented pandemic, years of trying production and market conditions, and severe winter storms, we should be utilizing every tool we have to get them the aid they need. However, this administration's restrictions on re-opening FPAC facilities have exacerbated the struggles of farm families across the country.

As you know, through FPAC, the U.S. Department of Agriculture helps to implement programs designed to mitigate the significant risks of farming through crop insurance services, conservation programs, technical assistance, commodity programs, lending, and disaster programs. One key component of FPAC is the Farm Service Agency, which helps to provide America's farmers with a strong safety net through the administration of farm commodity and disaster programs.

However, due to this administration's COVID Workplace Safety Plan, these facilities are required to maintain staffing at low levels for the entire agency and telework is being strongly encouraged. While the intent behind this plan may be noble, farmers and ranchers have expressed dissatisfaction with the widespread setbacks they have experienced in your offices' ability to process relief nationwide, due to the limits imposed. Moreover, many farmers struggle with accessing reliable broadband, further aggravating the difficulty that they face in engaging their local FSA office by computer. These challenges could greatly impact the farm families that we represent, which is why we are urging you to reconsider the restrictions.

In recent years, the agriculture industry has dealt with numerous setbacks which have created a need to bring relief and support to the food and agriculture industry. Unfortunately, this administration's one-size-fits-all approach to staffing only amplifies these setbacks and will have grave implications if they are not rectified immediately. As such, we request a meeting with you to discuss these implications, and we urge this administration to reconsider these actions and to

make a commitment to our farmers and ranchers by opening these aid facilities through an exemption to your COVID Workplace Safety Plan.

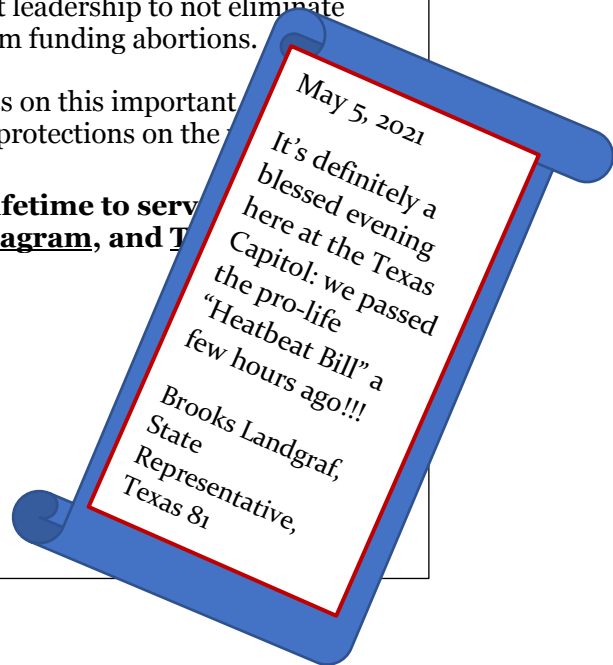

SPICY STRAWBERRY-GOAT CHEESE CROSTINI

INGREDIENTS

- 1 (12-oz.) French baguette
- 2 cups strawberries, chopped
- 1 tablespoon jalapeño chile, minced
- 2 tablespoons honey
- 1 tablespoon fresh lime juice
- ¼ teaspoon kosher salt
- 1 teaspoon softened goat cheese (from 2 [4-oz.] logs)
- Fresh mint, chopped



DIRECTIONS

- **Step 1** Cut French baguette into ¼-inch-thick diagonal slices; place on a large baking sheet. Bake at 350°F until lightly toasted, about 10 minutes. Cool completely, about 20 minutes.
- **Step 2** Stir together chopped strawberries, minced jalapeño chile, honey, fresh lime juice, and kosher salt in a small bowl.
- **Step 3.** Spread about 1 rounded tsp. softened goat cheese on each baguette slice. Top goat cheese with 1 slightly rounded tsp. strawberry mixture. Sprinkle with chopped fresh mint.

APRIL SALES TAX CHECK

The City of Odessa received its April sales tax check, in the amount of, \$3,355,377.84.

The City of Odessa received its April sales tax check, in the amount of, \$3,355,377.84. This amount includes the Economic Development sales tax of ¼ cent. The City of Odessa will receive \$2,684,302.27 and the Odessa Development Corporation will receive \$671,075.57.

The City saw an decrease in sales tax revenue with April's sales tax revenue total of \$2,684,302.27 which reflects a \$(1,177,332.57), or (30.49)% as compared to April 2020.

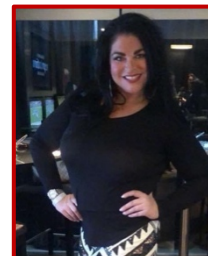
The year-to-date total sales tax revenue for fiscal year 2020-21 is up 13.59%, or \$2,709,365.96 as compared to budgeted amount expected at this point in the fiscal year.

In addition, the 2020-21 year-to-date amount is below the previous fiscal year-to-date amount by \$(8,065,972.17) or (26.26)%. The City has budgeted \$36,000,000.00 in net sales tax revenues for this current fiscal year.

Sales tax revenue is generated by sales tax revenue from two months prior to collection, i.e., April's collection is based on February sales.

CASA of the Permian Basin trains Volunteers to advocate for the best interests of abused and neglected children in the court system to ensure that each child is placed in a safe, permanent and healthy environment.

What is CASA? CASA is a national volunteer movement that began more than 30 years ago, when Judge David Soukup in Seattle decided he needed to know more about the children whose lives were in his hands. His solution was to ask community volunteers to act as a “voice in court” for abused and neglected children. These Court Appointed Special Advocates™ (CASAs) provided him with the detailed information he needed to safeguard the children’s best interests and ensure that they were placed in safe, permanent homes as quickly as possible. Today, the CASA movement has evolved into one of the largest volunteer organizations in the country. In Texas, there are 68 local CASA programs with more than 5,000 volunteers serving 20,451 foster children.

Mr. Victor Avila is a retired Supervisory Special Agent with the U.S. Immigration and Customs Enforcement (ICE), Homeland Security Investigations (HSI), under the U.S. Department of Homeland Security (DHS). ICE enforces federal laws governing border control, customs, trade, and immigration to promote homeland security and public safety.

Mr. Avila has been recognized by ICE and HSI for his exemplary service and professional accomplishments while serving as Special Agent at the El Paso Field Office and as an Assistant Attaché assigned to the U.S. Consulate in Ciudad Juarez and U.S. Embassies located in Spain, Portugal, and Mexico City. Mr. Avila served as an accredited diplomat and liaison to the aforementioned governments conducting international complex criminal investigations in a wide range of violations such as human trafficking/smuggling, drug trafficking, financial violations, arms trafficking, commercial fraud and counter terrorism.

While on official assignment in Mexico, Special Agent Avila suffered multiple gunshot wounds and survived a violent ambush by the Mexican Los Zetas drug cartel where Special Agent Jaime Zapata tragically lost his life.

Mr. Avila has been recognized for Excellence in Law Enforcement by the ICE Hispanic Agents Association; The Director's Award for Operation in Plain Sight in Mexico; Homeland Security Investigations Excellence in Public Service Award; The Valor Award by the Federal Law Enforcement Officers Association (FLEOA); Medal of Valor for Outstanding Bravery by the National Latino Peace Officers Association; the Medal of Valor by the Hispanic American Command Officers Association (HAPCOA); and the NYPD Heroism Award by the Global Alliance of Hispanic Law Enforcement Professionals.

Mr. Avila began his very successful law enforcement career as a United States Probation Officer for the U.S. Courts and as a District Parole Officer for the Texas Department of Criminal Justice. He holds a Bachelor of Science Degree in Criminal Justice from the University of Texas at El Paso while focusing on the identity among Hispanic-Americans along the border. Today, he serves to honor the memory and the dedicated service of SA Jaime Zapata. Mr. Avila is an advocate for border security, immigration reform, human trafficking awareness and the protection of our sovereignty.

Mr. Avila has been featured on FoxNews, i24News, Univision, OANN, Telemundo and various Syndicated Radio and Podcast interviews. Javier Joven was elected December 15th, to the Odessa City Council Mayor position and is serving as Mayor of the City of Odessa, Tx. Javier was born and raised in Odessa, TX. He is the youngest of three siblings born to Jose A Joven and Yolanda Joven (deceased) both of Del Rio, Tx.

Javier Joven is the first Hispanic to be elected in the history of municipal elections in Odessa, Tx. "Mayor Joven described the win as an improbable victory in the eyes of people, but a glorious victory with the help of God and his volunteers."

Javier Joven attended both Ector High School and Odessa High School. Upon graduation Javier attended Midland College. He also studied culinary arts and attained many accolades as Sous Chef, Pastry Chef in his 10 yrs. career traveling the country working for various corporate hotels and prestige's country clubs as far as New York State.

Javier is also the sole-owner of A1-Roofing and Framing and A1-Roofing and Construction.

Javier is a former City member of Odessa's City Council District 5 having been elected to two terms 1995-1997,1998-1999. He was the first Hispanic to be appointed to the Ector County Vice-Chair. From there he was elected Ector Co. Pct. Chair #204 since 2012-to Present. Javier has served on various governmental and non-profit boards through Odessa, TX. including these notable boards past and present:

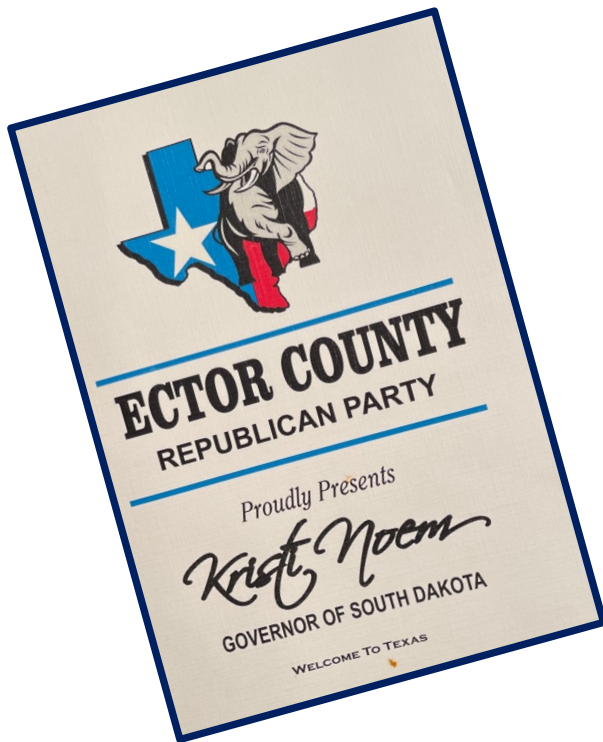
